National Council for Teacher Education, a statutory body under the Ministry of Human Resource Development invites applications from experienced retired officers who have worked in the Central or State Govts or Union Territories Administration or Public Sector Undertakings or Semi Govt or Autonomous or Statutory Organizations for being engaged as Finance Consultant in NCTE Hq at New Delhi. The qualifications, eligibility and remuneration are as given below:


Qualification – The Consultant proposed to be engaged should be a graduate and have sufficient knowledge of finance and accounting in Government/Public sector institution. He should have worked at the level of Section Officer/Under Secretary or equivalent in the Govt/Autonomous bodies. He should also possess an experience of at least 5 years in Finance and Accounts field. The engagement will be initially for a period of six months.

Age Limit – Should not be more than 65 years' of age as on 31st August, 2015.

Remuneration – The consolidated remuneration would be as under:

- i) Officers retired in Section Officer grade or equivalent with 3 years experience - Rs. 35,000/-p.m
 - ii) Officers retired in Under Secretary grade or equivalent with 3 years experience - Rs.42,000/- p.m.
- (There shall be a TDS deduction at source as per rules)

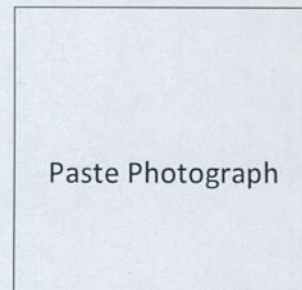
